
UNLOCKING TT\$1.5 BILLION IN 3 YEARS: A Thriving Future, Invested Today.

InvesTT has successfully secured TT\$1.48 billion in investment commitments for local and foreign projects during the first three years of its four-year strategic plan (Fiscal 2021-2024), spanning from 2021 to 2023. The most recent Fiscal year, ending in September 2023, witnessed a remarkable achievement as InvesTT recorded its highest investment value in three years, totaling TT\$719 million in Local and Foreign Direct Investment. This accomplishment reflects an impressive 159% growth compared to the TT\$278 million in committed investments seen in 2021.

TRIPLE-YEAR TARGET ACHIEVEMENT

Since the inception of InvesTT's strategic plan in 2021, the investment promotion agency (IPA) has recorded consistent annual growth of 75% in 2022 and 48% in 2023. Although InvesTT's strategic investments target for Fiscal 2023 was TT\$280Mn, the team challenged itself to a stretched target of TT\$750Mn and was successful in achieving 96% of same. Similar growth in jobs projected was seen with actual achievements surpassing targets by 149% and 118% respectively.


